Thank you for your interest in our 50+ year tradition. Kettering Holiday At Home is more than just a Labor Day gathering; it is the coming together of neighbors in a celebration of community pride and spirit with the help of music, crafts and entertainment. You don't have to live here to attend...this is your invitation to food, folks and fun!

Held in the spacious setting of pedestrian friendly Lincoln Park Civic Commons, the Arts & Crafts show is the most anticipated attraction for the majority of people attending Holiday At Home. But, that isn't all that brings people out to this annual event. Holiday at Home offers live music, food for all tastes, a comprehensive children's activity area, adult and children's karaoke, classic cars and many more activities to see and do. Major Holiday at Home events include the Coronation Ball Saturday evening and the Parade Monday morning.

If you wish to join the family of vendors who regularly attend our show, please review the following guidelines we have instituted to make your experience enjoyable and profitable.

- Acceptance is based on quality and originality of work, compliance with show requests and the requirements of exhibitor cooperation.
- Applicants must submit a minimum of three (3) recent photographs of the merchandise you intend to sell. Only items that are shown in the photos will be judged for acceptance, items without prior acceptance will be refused for display or sale. All previous vendors with photos on file will be judged on previously received material unless properly updated with the chairperson of Arts & Crafts before the filing deadline. Please identify all photographs on the back with the business name and contact information.
- Artists may share booth space with another artist. However, a minimum of three (3) recent photographs must be submitted for each artist. Work will be accepted or rejected according to the total represented media.
- No prefabricated or resale items are permitted. The exhibitor must handcraft all work. Dealers, agents and resellers will be rejected for consideration as exhibitors.
- A limited number of double spaces are available for rent. Last year's exhibitors are given first choice for these spaces. If any are still available they are assigned on a first-come, first-served basis. Be sure your application indicates your desire for a double space and your check includes the additional fee.
- A limited number of spaces have electricity available. Last year's exhibitors are given first choice for these spaces. If any are still available they are assigned on a first-come, first-served basis. Be sure your application indicated your desire for a space with electricity and your check includes the additional fee.
- Booth spaces are approximately 10 ft x 10 ft. Exhibitors supply all display equipment (tables, chairs, covers, etc.). All canopies must be freestanding due to the fact booths are on concrete and cannot be staked down.
- The deadline for applications is July 31 of the year of the event. Notification of acceptance or rejection will be sent on or about August 10th. Non-acceptance letters will include a return of submitted funds. Once your application is accepted, the vendor fee is non-refundable.
- Setup time will be provided on the Saturday before Labor Day starting at 9:00 am and will continue until opening time on Sunday. Although security is provided both Saturday and Sunday evenings and nights you must assume all responsibility for any and all merchandise left on the premises. Kettering Holiday at Home cannot be held responsible for any lost, stolen or damaged merchandise or items.
- All booths are assigned by the chairperson and the committee. Many hours of preparation and layout go into displaying the diversity of the Arts & Crafts available. If there are specific concerns that need to be addressed, please know that they are handled on a first-come, first-served basis. We try to accommodate your special needs and requests; however, we cannot make any guarantees or promises.
- **This is an outdoor show and will be held rain or shine. Refunds are not given due to inclement weather.**
